









## The Hudson Valley Bullshit Society

Official Minutes of the 4th HVBS Meeting June 19, 2013 at the Hoffman House in Kingston, NY.

- 1- On a bright, sunny clear day the Northern contingent in PC Wiz's Camry made a routine transit to the Hoffman House, arriving at 11:19 AM, only to find Ramrod had preceded us and was waiting in the parking lot. Ramrod pointed out that he had acquired a handicap parking tag and had taken the "handicap reserved" first space next to the entrance path.
